## HOUSE CONCURRENT RESOLUTION NO. 4

## RECOGNIZING THE DIVISION OF CORPORATIONS ON RECEIVING THE W.L. GORE AWARD.

1 WHEREAS, the University of Delaware recently announced that the Delaware Division of Corporations has been 2 named a 2008 recipient of the Gore Award of Excellence, the highest award given by the independent panel of Delaware 3 Quality Award examiners and judges; and 4 WHEREAS, the Delaware Quality Award was established in 1992 as a public-private partnership to promote and 5 recognize performance excellence throughout the state; and 6 WHEREAS, the Gore Award, named in honor of W.L. (Bill) Gore, recognizes an agency's strength and business 7 practices in multiple categories including leadership, strategic planning, customer focus, and business results; and 8 WHEREAS, the Division of Corporations' mission is to create business entities and generate revenue for the State 9 of Delaware while providing superior service to its customers; and 10 WHEREAS, the Division of Corporations offers its customers innovative expedited service options such as a 1-11 hour service guarantee; and 12 WHEREAS, the Division of Corporations has a long history of leveraging technology to boost efficiency and was 13 the first in the nation to develop a corporate database, workflow, and imaging system; and 14 WHEREAS, the Division of Corporations' website receives more visits than any other agency in Delaware state 15 government and offers customers a variety of popular services including online tax filings and name reservations, as well as 16 Live Online Chat for customers seeking incorporation, Uniform Commercial Code (UCC), or franchise tax information; 17 and 18 WHEREAS, the 100 dedicated and professional employees of the Division of Corporations handle a remarkable 19 1.2 million service requests and process more than 1.5 million tax and fee transactions every year; and 20 WHEREAS, incorporations and UCC revenue collected through the Division of Corporations accounts for 22 21 percent of the State's general fund revenue; and
